

3. This Affidavit is based on my personal knowledge and information provided to me by experienced JND employees and, if called on to do so, I could and would testify competently thereto.

CLASS MEMBER DATA

4. On March 23, 2022, JND received spreadsheets from Defendants containing, among other information, the names and mailing addresses for a total of 5,068 rows of Settlement Class Member information.

5. Prior to mailing notices, JND analyzed the raw data to consolidate duplicate records within the spreadsheets and determined a total of 4,932 unique Settlement Class Members. JND updated the Settlement Class Member contact information using data from the National Change of Address (“NCOA”) database.² The Settlement Class Member data was promptly loaded into a secure database established for this Action.

NOTICE PLAN SUMMARY

6. JND administered the Notice Plan that was designed to reach at least 70% of likely Class Members. The Notice Plan included a digital effort with the leading digital network (Google Display Network or “GDN”) and top social media sites (Facebook and Instagram). A direct notice effort including mail notice to approximately 4,932 known Class Members extended reach further.

7. JND also established and maintained a Settlement website, mailing address, email address, and toll-free telephone number, as stated below.

² The NCOA database is the official United States Postal Service (“USPS”) technology product which makes changes of address information available to mailers to help reduce undeliverable mail pieces before mail enters the mail stream. This product is an effective tool to update address changes when a person has completed a change of address from with the USPS. The address information is maintained on the database for 48 months.

DIGITAL NOTICE EFFORT

8. On April 4, 2022, JND caused the digital effort to launch with GDN, Facebook and Instagram. The digital effort concluded on May 1, 2022, delivering 69,157,488 impressions to adults 18 years of age or older (Adults 18+) throughout New York, New Jersey, Connecticut and Pennsylvania, with an emphasis towards Adults 18-34 in the New York City metro area. Overall, the digital effort delivered 627,488 impressions more than what was originally planned. A portion of the GDN impressions were allocated to audiences who have browsed for content related to laundromats, washing machines and smart cards. The GDN effort also included Spanish language digital ads served to Spanish sites.

9. The digital ads were served across all devices (desktop, laptop, tablet, and mobile), with an emphasis on mobile. Screenshots of the Digital Notices as they appeared on GDN, Facebook and Instagram are attached as **Exhibit A**.

10. Additionally, on June 14, 2022, at the request and expense of Class Counsel, JND coordinated a second distribution of the Digital Notice. The second distribution has delivered 1,037,466 impressions thus far and is set to conclude on July 11, 2022.

POSTCARD NOTICE

11. Pursuant to the terms of the Settlement Agreement, on April 11, 2022, JND mailed the Court-approved postcard notice (“Postcard Notice”) via USPS first-class mail to all 4,932 unique Settlement Class Members. The Postcard Notice included a scannable QR Code that would take recipients to the Settlement Website. A representative sample of the Postcard Notice is attached hereto as **Exhibit B**.

12. As of the date of this Affidavit, JND tracked 138 Postcard Notices that were returned to JND as undeliverable. Of these 138 undeliverable Postcard Notices, JND conducted

additional advanced address research through TransUnion and received updated address information for 37 Class Members. JND promptly re-mailed Postcard Notices to these 37 Class Members (of which five (5) were returned as undeliverable).

13. As of the date of this Affidavit, 4,826 Class Members were mailed a Postcard Notice that was not returned as undeliverable, representing 97.9% of the total Settlement Class that was mailed a Postcard Notice.

14. Additionally, on June 17, 2022, at the request and expense of Class Counsel, JND mailed Reminder Postcard Notices (“Reminder Postcard”) to 4,695 Class Members who had not filed a Claim Form at that time. As of the date of this Affidavit, JND tracked 141 Postcard Notices that were returned to JND as undeliverable. A total of 4,554 Class Members were mailed a Reminder Postcard that was not returned as undeliverable, representing 97.0% of the total Settlement Class that was mailed a Reminder Postcard. A representative sample of the Postcard Notice is attached hereto as **Exhibit C**.

SETTLEMENT WEBSITE

15. On March 24, 2022, JND established a Settlement Website (www.HercuesLaundryCardSettlement.com), which hosts copies of important case documents, including the Class Action Settlement Agreement, Class Notice (in English and in Spanish), answers to frequently asked questions, and contact information for the Administrator. Additionally, the Settlement Website allowed Class Members to File a Claim Form or submit a Request to be Excluded electronically.

16. On May 13, 2022, Class Counsel filed Plaintiffs’ Motion for Attorneys’ Fees, Costs, Expenses, and Named Plaintiffs’ Enhancement Awards, and all papers pertaining to that Motion were uploaded to the Settlement Website on the same day.

17. As of the date of this Affidavit, the Settlement Website has tracked 23,275 unique users with over 41,408 page views. JND will continue to update and maintain the Settlement Website throughout the administration process.

TOLL-FREE INFORMATION LINE

18. On March 24, 2022, JND established a case-specific toll-free number, 1-888-964-2126, for Settlement Class Members to call to obtain information regarding the Settlement. Callers have the option to listen to the Interactive Voice Response (“IVR”) system which directs Settlement Class Members to the Settlement Website. The toll-free number is accessible 24 hours a day, seven days a week.

19. As of the date of this Affidavit, the toll-free number has received 43 incoming calls. JND will continue to maintain the toll-free number throughout the settlement administration process.

REQUESTS FOR EXCLUSION

20. The Postcard Notice informed recipients that any Class Member who wished to exclude themselves from the proposed Settlement (“opt-out”) must do so by either submitting a Request to be Excluded electronically on the Settlement Website, or by mailing an exclusion letter to the Settlement Administrator, postmarked or submitted on or before May 31, 2022.

21. As of the date of this Affidavit, JND has not received any requests for exclusion.

OBJECTIONS

22. The Postcard Notice informed recipients that any Class Member who wished to object to the proposed Settlement could do so by filing a written objection with the Court, postmarked on or before May 31, 2022.

23. As of the date of this Affidavit, JND has not received, and is not aware of, any objections.

CLAIM FORMS RECIEVED

24. The Postcard Notice informed recipients that Settlement Class Members must file a Claim Form if they wish to receive a payment from the Settlement, and that those wishing to do so, could File a Claim Form on the Settlement Website by scanning the QR Code on the Postcard Notice, visiting the File a Claim page on the Settlement Website, or by printing and mailing a copy of the Claim Form to JND, postmarked or submitted on or before August 26, 2022. A representative sample of the Claim Form is attached hereto as **Exhibit D**.

25. As of the date of this Affidavit, JND has received 378 Claim Forms (375 electronic and three (3) mailed). JND expects additional timely-filed Claim Forms to be filed electronically or postmarked prior to the filing deadline. JND is in the process of receiving, reviewing, and validating the submitted Claim Forms on an ongoing basis.

REACH

26. To calculate media reach, JND used a Comscore, Inc.³ tool. According to this reputable media reach platform, the digital effort reached more than 70% of likely Class Members. The direct notice effort to known Class Members extended the reach further. The delivered reach is similar to that of other court approved programs and meets the standard set forth by the Federal Judicial Center.

CONCLUSION

27. In my opinion, the Notice Plan provided the best notice practicable under the



circumstances; was reasonable and constituted due, adequate, and sufficient notice; met all applicable requirements of CPLR, the Due Process Clauses of the United States and New York Constitutions, and the rules of the Court; and is consistent with other similar court-approved notice programs. The Notice Plan effectively reached more than 70% of Class Members and provide them with the opportunity to review a plain language notice with the ability to easily take the next steps to learn more about the Settlement, including their right to object to or exclude themselves from the proposed Agreement, and to appear at the Final Approval Hearing.

This notice is to inform you of the settlement of a class action lawsuit with Hercules Corp. (“Hercules”), the Defendant in this case. Plaintiffs Richard McCall and Abraham Libman allege that Defendant misrepresented the value of its reloadable cash cards designed for use with laundry machines that are provided by and serviced by Defendant (“Laundry Cards”) by setting the reload amounts and laundry machine prices such that the Laundry Cards were guaranteed to have a remainder balance, and then charging consumers a \$5 processing and handling fee to collect the unused balance, without clearly and conspicuously disclosing that fee. Hercules denies these allegations.

Am I a Settlement Class Member? Our records indicate you may be a Class Member. Class Members are persons who possessed and used a Hercules Laundry Card after January 1, 2017 and stopped using their Hercules Laundry Card prior to July 13, 2021 and no longer possess their Hercules Laundry Card.

What Can I Get? You **must** submit a Claim Form (see instructions below) to receive a share of the Settlement Fund. You may be entitled to receive a **\$3.00** cash payment if you possessed and used a Hercules Laundry Card after January 1, 2017 and stopped using the Hercules Laundry Card prior to July 13, 2021. Alternatively, you may receive a cash award of **\$15.00** if you: (i) were charged processing and handling fees in connection with recovering unused funds on a Hercules Laundry Card; or (ii) sent in your Hercules Laundry Card to Hercules for a recovery of unused funds, but had your card returned to you because it had less than a \$5 balance. These cash payments may be subject to *pro rata* adjustment depending on the number of valid claims that are filed. A Settlement Sum of up to \$2,362,500.00 will be established to pay all valid claims submitted by the Settlement Class. Notice and administration expenses, approved attorneys’ fees and costs to Class Counsel, and Service Awards to the Class Representatives will be paid by Defendant separately from the Settlement Sum and will not derogate from the Settlement Sum.

How Do I Get a Payment? You **must** complete and submit a Claim Form to receive a payment from the Settlement Sum. You may submit a Claim Form either electronically on the Settlement Website by visiting www.HerculesLaundryCardSettlement.com, or by printing and mailing in a paper Claim Form, copies of which are available for download at www.HerculesLaundryCardSettlement.com. Claim Forms must be submitted online by **11:59 p.m. EST on August 26, 2022** or postmarked and mailed by **August 26, 2022**.

What are My Other Options? You may exclude yourself from the Class by sending a letter to the settlement administrator no later than **May 31, 2022**. If you exclude yourself, you cannot get a settlement payment, but you keep any rights you may have to sue the Defendant over the legal issues in the lawsuit. You and/or your lawyer have the right to appear before the Court and/or to object to the proposed settlement. Your written objection must be filed no later than **May 31, 2022**. Specific instructions about how to object to, or exclude yourself from, the Settlement are available at www.HerculesLaundryCardSettlement.com. If you file a claim or do nothing, and the Court approves the Settlement, you will be bound by all of the Court’s orders and judgments. In addition, your claims relating to the alleged conduct in this case against the Defendant will be released.

Who Represents Me? The Court has appointed Bursor & Fisher, P.A. to represent the class. These attorneys are called Class Counsel. You will not be charged for these lawyers. If you want to be represented by your own lawyer in this case, you may hire one at your expense.

When Will the Court Consider the Proposed Settlement? The Court will hold the Final Approval Hearing at **11:00 a.m. on July 12, 2022** at the Supreme Court of the State of New York, County of Westchester, Courtroom 103, 111 Dr. Martin Luther King Jr. Blvd., White Plains, NY 10601. At that hearing, the Court will: hear any objections concerning the fairness of the Settlement; determine the fairness of the Settlement; decide whether to approve Class Counsel’s request for attorneys’ fees and costs; and decide whether to award the Class Representatives \$5,000 each for their services in helping to bring and settle this case. Defendant has agreed that Class Counsel may be paid reasonable attorneys’ fees, costs, and expenses in an amount to be determined by the Court. Class Counsel is entitled to seek no more than one-third of the Settlement Sum, but the Court may award less than this amount.
